Board of Visitors Members Visit FSU Law

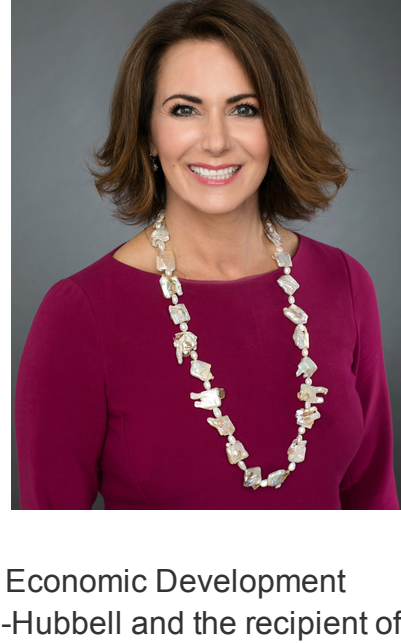

Jeanne M. Miller is president and CEO of the Jacksonville Civic Council, where she works closely with Northeast Florida leaders to identify and promote solutions to the region's most complex business and public policy challenges. Immediately prior to joining the council, Miller served as general counsel and vice president of strategic initiatives at Florida State College at Jacksonville, where she oversaw the transition from community to four-year college, and was instrumental in establishing public-private partnerships to benefit students and spur economic growth. Miller's previous experience includes corporate and municipal legal practice and service as both deputy executive director and interim executive director of the Jacksonville Economic Development Commission. AV-Preeminent-rated by Martindale-Hubbell and the recipient of a number of peer-reviewed honors, she is a past member, chair and vice-chair of the Judicial Nominating Commission for the First District Court of Appeal, as well as a former member and vice-chair of the Fourth Circuit Judicial Nominating Commission. Miller is very active in her community and has served on a number of regional boards. In addition to serving as a member of the national FSU Alumni Association Board of Directors, the Leadership Jacksonville and Leadership Florida graduate is currently treasurer of the Jacksonville Transportation Authority and chair of Goodwill Industries of North Florida.

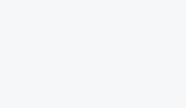
