Registration for FSU Law's Fall 2022 Interview Program (OCI) is now open for employers. The law school can accommodate employers for in-person, on campus interviews or for remote interviews via Zoom. Talented FSU Law students are available to interview for full-time and part-time law clerk, intern, or associate positions. This year's fall interview program runs from Monday, August 1, through Friday, October 14, but dates for fall interviews historically fill up early, so employers should register now to ensure they secure their preferred interview dates. ### Alum Profile: Daniela Donoso ('20)

Daniela Donoso is serving a two-year fellowship through Equal Justice Works, sponsored by Greenberg Traurig, LLP, and The Florida Bar Foundation, and hosted by Legal Services of North Florida (LSNF). Her fellowship project aims to create a comprehensive immigration advocacy program in North Florida to serve low-income immigrants and immigrants who are crime victims, and to establish immigration protocols, procedures, and resources for LSNF's staff and community partners. As part of her fellowship, Donoso has, among other things, conducted Legal Services of North Florida's first-ever immigration legal clinic in Tallahassee and Panama City Beach, and given multiple community education and outreach presentations, reaching over 900 community members. Additionally, Donoso is LSNF's partner with the College of Law's Farmworker & Immigration Rights Clinic's Afghan Legal Assistance Project, which was created to help Afghan refugees who have settled in Tallahassee and need legal assistance. The project is currently seeking volunteers to represent asylum seekers and special immigrant visa applicants, and to assist in preparing families' temporary protected status applications in the project's virtual or hybrid pro se clinics, the first of which will occur on June 25.
