## Attorney General Moody Visits FSU Law

On Monday, Florida Attorney General Ashley Moody visited the law school to speak with alumni serving on the FSU Law Board of Visitors. Moody discussed her career path and how she is using lessons learned in practice and on the bench to make Florida a stronger state; rewarding aspects of serving as the state's chief legal officer; some of the projects on which the Attorney General's Office is currently working—including advocating for legislation to better protect the state's seniors—and the unique partnership her office has with FSU Law.

"I will continue to be a partner," said Moody when discussing her wish to continue to collaborate with FSU Law and to hire student interns. "What we do now in developing young adults will make a lasting impact on the state of Florida." She also commented that she would like to build upon the existing partnership.

Moody's visit was part of periodic meetings of the Board of Visitors, which serves as the senior support organization for FSU Law. Members are comprised of alumni and close friends of the law school who serve as the dean's cabinet in an advisory capacity.

## Student Profile: 2021 Grad Emmalyn Dalton

**Desired Practice Location:** Open to any area  
**Field of Law Sought:** Criminal justice, juvenile justice, prison reform, children's advocacy

Originally from Boynton Beach, Florida, Emmalyn Dalton earned a bachelor's degree in psychology, with a minor in business administration from the University of Florida. She graduated from FSU Law last weekend.

Since December 2020, Dalton has interned with the FSU College of Social Work Institute for Family Violence Studies, where she worked with Professor Karen Oehme ('87) to create an



online course for judges on the impact of intimate partner violence in relation to the court system. She researched and compiled information on compassion fatigue, vicarious trauma, and burnout to be used by college professors and administrators. Beginning her 1L summer and through the rest of law school, Dalton participated in the FSU Public Interest Law Center Children's Advocacy Clinic and became a student advocate for their Children in Prison Project.

Dalton worked with young clients with special and diverse needs. She conducted legal research and wrote appellate briefs for incarcerated juveniles based on the Graham/Miller/Montgomery line of decisions out of the U.S. Supreme Court. She worked with state representatives in the hope of passing anti-solitary confinement bills in the Florida Legislature and created a documentary on the realities of solitary confinement for children. During her 2L summer, Dalton externed at the Florida First District Court of Appeal, where she prepared legal summaries, drafted opinions and compiled legal research on topics ranging from motions for judgment of acquittal to termination of parental rights actions. Prior to entering law school and during her 1L year, Dalton interned at Personal Injury of Florida, where she drafted motions, memos, complaints and other documents for personal injury clients, helped prepare for trial, took depositions, interviewed clients and compiled research on legal topics ranging from medical malpractice to actions for replevin.

During law school, Dalton was a member of the Phi Delta Phi Honor Society, the Student Bar Association, the Women's Law Symposium, the Association for Criminal Justice, and If/When/How: Lawyering for Reproductive Rights. 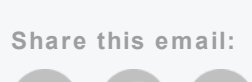
