On Monday, March 25, FSU Law hosted the Honorable Anuraag "Raag" Singhal, of the United States District Court for the Southern District of Florida, as part of our Jurist in Residence Program. Judge Singhal participated in Professor Wayne Logan's Criminal Procedure: Adjudication class, speaking with students and answering questions, before attending a lunch with student members of several student organizations and law school journals. During the lunch, Judge Singhal spoke about striking a balance between one's personal and professional life and the importance of federal clerkships. In the afternoon, Judge Singhal conducted mock

interviews with several FSU Law students who are interested in federal clerkships before attending a reception with FSU Law faculty members and invited judges.

Judge Singhal was appointed to the U.S. District Court for the Southern District in 2019, and he served on the Seventeenth Judicial Circuit Court of Florida from 2011 to 2019. Before his service on the bench, Judge Singhal worked at a civil litigation firm, served as an assistant state attorney in Broward County, and was a successful criminal defense trial lawyer for eighteen years, during which time he handled over two hundred jury trials. Many thanks to our Career Services Office for organizing Judge Singhal's visit—it was our pleasure to welcome him to the law school and to be able to provide students with opportunities to interact with a federal judge.



Vilceus is completing an externship with the Second Judicial Circuit Office of the Public Defender in Tallahassee, where he conducts legal research and analysis of statutes, regulations, and case law and drafts motions and legal memoranda. Vilceus also was a law clerk for the public defender's office during the summer before his 3L year. During the fall 2023 semester, Vilceus was a teaching assistant for the College of Law's LL.M. program. His work included facilitating small group discussions, answering students' questions, and providing guidance on legal writing concepts and techniques. As a 2L, Vilceus was a student advocate with the College of Law's Farmworker & Immigration Rights Clinic. During his time there, he conducted client intake interviews, drafted an affidavit, and prepared and filed various documents for clients, including a Temporary Protected Status Application for Asylum and for Withholding of Removal.

At FSU Law, Vilceus has continued to volunteer with the Farmworker & Immigration Rights Clinic, and he was a member of the Journal of Transnational Law & Policy as a 2L. He is fluent in French and Creole and is a board member for the Community Empowerment Network, based in Port Au Prince, Haiti.
