# **Environmental Distinguished Lectures**



**ROBERT PERCIVAL,** Robert F. Stanton Professor of Law and Director, Environmental Law Program, University of Maryland Francis King Carey School of Law Wednesday, October 19, at 3:30 P.M.

Professor Robert Percival is internationally recognized as a leading scholar and teacher in environmental law. Since 1992 he has been the principal author of the most widely used casebook in environmental law, *Environmental Regulation: Law, Science & Policy*, now in its seventh edition. Professor Percival has served as senior attorney for the Environmental Defense Fund, a law clerk for Judge Shirley M. Hufstedler, of the U.S. Court of Appeals for the Ninth Circuit, and for U.S. Supreme Court Justice Byron R. White.

**NICOLE STELLE GARNETT,** John P. Murphy Foundation Professor of Law, University of Notre Dame Law School Wednesday, February 1, at 3:30 P.M.

Professor Nicole Stelle Garnett is the author of numerous articles on property, land use, urban development, local government law and education policy. She is the author of *Ordering the City: Land Use, Policing and the Restoration of Urban America* (2009). Before joining Notre Dame Law in 1999, she was a staff attorney at the Institute for Justice, a non-profit public-interest law firm in Washington, D.C., and was a law clerk for Judge Morris S. Arnold, of the United States Court of Appeals for the Eighth Circuit, and for Associate Justice Clarence Thomas, of the United States Supreme Court.



# Municipal Utilities and Cooperatives: Transitioning to a Lower-Carbon Future

Next March, FSU Law will host a conference addressing the challenges and opportunities that municipally-owned electric utilities and electric co-operatives have faced as they have transitioned to lower-carbon sources of electricity. Conference panelists will include executives and attorneys from a variety of utilies, and legal scholars from nonprofit organizations. The conference is co-sponsored by the Florida State University College of Law and the University of North Carolina School of Law Center for Climate, Energy, Environment and Economics and will take place on Friday, March 24, 2017 at 8:00 A.M.

**BLAKE HUDSON**, Burlington Resources Professor of Environmental Law and Edward J. Womac, Jr. Professor of Energy Law, Louisiana State University Paul M. Herbert Law Center

Wednesday, October 5, at 12:30 P.M.

Professor Blake Hudson's research considers how property, land use, and natural resources law and policy intersect with environmental and constitutional law, with specific focus on the issue of federalism as it relates to land use and the environment. Professor Hudson holds a joint appointment with the LSU School of the Coast and Environment, where he teaches natural resources and environmental law-related coursework. Before joining LSU, Professor Hudson practiced law with Baker Botts in Houston, Texas, and was an assistant professor at Stetson University College of Law.





**ROBERTA MANN**, Mr. & Mrs. L.L. Stewart Professor of Business Law, University of Oregon School of Law Wednesday, November 16, at 12:30 P.M.

Professor Roberta Mann teaches and writes about tax law, with a particular emphasis on how the tax system affects the environment. Professor Mann served as the only tax lawyer on the National Academies of Science committee studying the greenhouse gas impact of the Internal Revenue Code. She is active with the ABA Tax Section, the National Tax Association, and the Portland Tax Forum, and regularly speaks at the annual Global Conference on Environmental Taxation. Before beginning her teaching career, Professor Mann served on the staff of the Joint Committee on Taxation and worked for the Office of Chief Counsel of the Internal Revenue Service in Washington, D.C.

# Environmental Law Society

Our student organization, the Environmental Law Society, brings together law students interested in environmental and natural resource issues, and remains active in programming events that bring Florida issues to the FSU Law community. **SARAH LOGAN BEASLEY ('16)** is currently a law clerk for Judge Robert Hinkle, of the U.S. District Court for the Northern District of Florida, and next year will be a law clerk for Judge Mark Walker, also of the U.S. District Court for the Northern District of Florida. Beasley's moot court team was a semifinalist in the Pace Moot Court competition two years in a row, and she was named Best Oralist for the 2016 competition.



"I was born and raised in Tallahassee, Florida, to a family full of lawyers, including my dad, a 1974 graduate of FSU Law. Growing up, my parents instilled in me a deep appreciation for the environment--particularly the Gulf Coast--and my dream career for the past 10 years has been to work as a park ranger for the National Park Service. I spent three summers in high school building hiking trails in various national parks and other public lands with the Student Conservation Association. A penchant for argument and persuasive story-telling eventually led me down a different but equally fulfilling path to study environmental law at FSU Law. Now you could say I spend my days as a metaphorical park ranger in the legal system, exploring and analyzing the numerous legal issues presented to me daily. I couldn't have found a better way to start my career."
