COLLEGE OF LAW SCHOLARSHIPS

The Office of Admissions handles the awarding of scholarships to incoming first year law students. These awards are disbursed in the fall and spring semesters. They are not disbursed in summer terms. Please refer to your admissions award letter for a breakdown of how and when your scholarship will be disbursed.

Additional scholarship opportunities are available throughout the academic year and are announced by the Office of Student Advancement. Most scholarships disburse during the fall and spring semesters, with limited exceptions for summer disbursements. The Office of Student Advancement maintains a Canvas site that includes information about available internal and external scholarship and writing competition opportunities.

FEDERAL LOANS, INTEREST RATES AND FEES/BORROWING LIMITS

LOAN COUNSELING RESOURCES

FSU OFFICE OF STUDENT FINANCE

The Office of Student Finance serves as a chief financial resource for students at FSU. Responsibilities of the office include the invoicing and collection of tuition and fees, debt management counseling, third-party billing, and federal, state, and institutional financial aid accounting. The office also serves as the University's tuition waiver liaison.

COLLEGE OF LAW OFFICE OF ADMISSIONS

College of Law first-year scholarships are awarded to students on the basis of merit, considering both the LSAT/GRE score AND cumulative UGPA. Admitted students are automatically considered and are notified upon admission if they are awarded a scholarship. All first-year scholarships are for three years. Scholarship awards, or a lack of scholarship award, is non-negotiable.

ACCESSLEX INSTITUTE

The Florida State University College of Law has established a valuable partnership with AccessLex, a leading organization dedicated to improving financial literacy among law students.

Beginning in the 1L year, we offer comprehensive debt counseling designed to help students understand the complexities of student loans, budgeting, and financial planning. The support continues to their 2L year with optional workshops on various topics such as "Five Habits for Financially Successful Lawyers" or "Student Loan Repayment Strategies for Legal Careers." This past Spring, 3L students attended a mandatory session on "Money and Your Career: Legal Salaries, Taxes, and Benefits," which offers in-depth insights into the financial realities they will face as new lawyers. Additionally, 3Ls are given the opportunity to participate in optional one-on-one financial coaching, allowing for personalized advice tailored to their specific needs and goals.

In the 2023-2024 academic year, we hosted a total of six events in partnership with AccessLex. Beyond these events, we ensure AccessLex resources are readily available to students through multiple channels, including our Canvas platform and updates in the Student Announcements. For the current academic year, 2024-2025, we have two events planned in collaboration with AccessLex for the Fall 2024 semester, including a mandatory session with the 2Ls.
