PROFESSIONAL SKILLS TRAINING

FSU College of Law offers a variety of robust, hands-on learning opportunities. Our rich curriculum is designed to equip students with practical tools for success in and outside of the classroom, including courses focused on litigation skills, transactional skills, and legislative and administrative practice skills.



- Under the guidance of professors, students work directly with clients on real legal issues through our Clinical Programs. Clinics include the Business Law Clinic, the Bankruptcy Law Pro Bono Clinic, the First Amendment Clinic, and our Public Interest Law Center, which houses a variety of clinics and projects that provide legal services to underrepresented individuals.
- Through our extensive **Clinical Externship Program**, students earn academic credit by working in more than 100 approved placements in outside law offices or courts. Placement areas include judicial, criminal, civil, legal services, appellate, business, and international.
- Our **Stoops Center for Law & Business, Election Law Center, Center for Environmental, Energy and Land Use Law, and Institute of Law, Technology & Innovation** host programming that features top scholars and practitioners from around the nation discussing cutting-edge topics.
