

Wayne Logan, FSU Law's Steven M. Goldstein Professor, was featured on an NPR segment titled "Internet sleuths are trying to solve the New York CEO killing."

The piece discusses the fatal shooting of UnitedHealthcare CEO Brian Thompson in Manhattan, which has set internet sleuths off on their own investigations into finding the killer and his motive after the suspect seemingly disappeared from one of the most surveilled cities in the U.S. In past highprofile cases, online sleuths have successfully tracked down suspects that have eluded the authorities.
