DEAN'S FUNDRAISING REPORT FOR 2022-2023



Dear Alumni and Friends:

This was a year of great success for the law school. The reputation of our outstanding students, faculty and alumni continues to blossom. We continue to attract some of the strongest students, as well as have had consistently strong bar passage and placement rates.

Private fundraising makes a critical difference at the law school, helping us to attract and to support the best students and faculty.

TOTAL GIFTS AND PLEDGES

Putting annual giving and larger gifts together, we raised a cash total of \$1,725,928 and unrealized new pledges in the amount of \$105,000, for a grand total of \$1,830,928.

ANNUAL GIVING FROM ALUMNI

This past year, 14% of our alumni made cash gifts to the law school. This level of participation places us within the nation's top law schools in terms of alumni giving rate. This level of alumni contributions enriches the life of the school and sends a powerful signal about the enthusiasm our alumni have for the school.

GIVING FROM STUDENTS

This past year, 62.2% of our students participated in the Student Give Back Campaign. Our student enthusiasm and generosity bodes well for the future. They are blazing the trail for us all!

LARGER GIFTS

This past year, cash payments received totaled \$500,000 towards \$605,000 of Larger Gift commitments. The "Cash Gifts By Level" portion of this report includes only cash payments made during the fiscal year, even if they were but a portion of a larger gift. Under the heading of "Recent Larger Gifts," we outline the larger gift commitments that we received in the 2022-2023 fiscal year.

We are deeply grateful to everyone who has contributed to our many successes. We shall continue to do our best to pay great dividends on the dollars you have invested in our school.

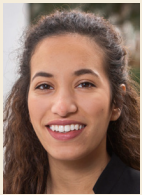

ENDOWED GIFT OPPORTUNITIES

ENDOWED SCHOLARSHIPS

Our single greatest need from private giving is endowed scholarships. To continue to serve our mission of providing access to all, including those from families of modest means, we will need significantly more scholarships. Scholarships are awarded according to the intent of the donor and may be based on merit, need, or other factors. *The endowed scholarship would be named after you or your designee.*

Minimum gift needed to create an endowed scholarship: \$50,000 (may be paid over time)

ENDOWED PROFESSORSHIPS AND CHAIRS

According to a 2018 study of law faculty scholarly impact, our faculty is #1 in Florida and #29 nationally. Our faculty members are being recruited by some of the nation's most prominent law schools. Endowed professorships and chairs provide salary supplements based on merit. Faculty members are appointed for five-year terms, with renewal contingent on continued scholarly productivity. Professorships and chairs give us the merit money we need to retain our top faculty. *The professorship or chair would be named after you or your designee.*

Minimum gift needed to endow a professorship: \$250,000 (may be paid over time)

Minimum gift needed to endow a chair: \$2,000,000 (may be paid over time)



The Edward Ball Eminent Scholar Chair in International Law has been instrumental in keeping **Frederick M. Abbott** at Florida State. He is highly regarded for his work in international intellectual property rights and global economic issues.

ENDOWMENTS FOR EXCELLENCE

Endowments for excellence are used, at the discretion of the law school, for purposes such as student scholarships, faculty incentives, general discretionary dollars, and funding for co-curricular activities including *Law Review*, Trial Team, and Moot Court. *The endowment for excellence would be named after you or your designee.*

Minimum gift needed to create an endowment for excellence: \$30,000 (may be paid over time)



Kelli Alces Williams, the Kelli Alces Williams, the Matthews & Hawkins professor of property, is an expert on corporate governance, fiduciary duties, trust, and consumer expectations in sophisticated markets. A professorship helps recruit and retain scholars like Williams.

ENDOWMENTS FOR PARTICULAR PROGRAMS

Private philanthropy has helped us take many of our existing programs to a new level of excellence. Our award-winning Moot Court and Trial Teams benefit from private contributions to supplement the dollars available to them for purposes such as traveling to regional and national competitions. Our Public Interest Law Center, which includes the Children's Advocacy Clinic, Claude Pepper Elder Law Clinic, Farmworker & Immigration Rights Clinic, and International Human Rights Clinic, relies on private contributions to help pay for some of the expenses involved in training students to provide effective legal services to the under-represented. An important goal of the law school is to raise substantial endowments to support special programs and co-curricular organizations. Some programs simply would not exist at the law school but for the generous support of our alumni.

Minimum gift needed to create an endowment to benefit a particular program: \$30,000 (may be paid over time)

DONOR RECOGNITION

We are delighted to recognize scholarships, professorships and other targeted gifts by naming them in honor of the donor or the donor's designee. In addition, we are pleased to acknowledge inter vivos gifts of \$200,000 or more with an oil portrait of the donor or the donor's designee that will be displayed in a prominent place at the law school. The Advocacy Center and the renovated spaces in the main classroom building give us many rooms to name to thank donors for gifts ranging from \$25,000 to \$5 million.

LARGER GIFTS FOR 2022-2023

We would like to specially thank those of you who made a larger gift commitment between July 1, 2022, and June 30, 2023. These gifts make it possible to continue the dynamic advancement of the academic programs and reputation of the law school.

Abb ('01, JD/MBA) and **Jennifer Payne** ('07, MS) have committed **\$145,000** for the renovation of the student-use lockers on the first floor of the main building. The funds shall be used for the purchase and installation of new lockers with digital locking mechanisms to replace the originally installed (1972) lockers still used to this day. Abb and Jennifer live in Hattiesburg, MS, where they focus on Payne Co.'s portfolio of growth businesses and their family foundation.

An **anonymous donor** has made a commitment of **\$80,000** to the already established Talbot "Sandy" D'Alemberte Distinguished Endowed Chair. In memory of Sandy D'Alemberte, the gift will allow the College of Law to recruit a legal scholar who has an expertise in constitutional law and shares D'Alemberte's passion for freedom of speech.

Patsy Palmer ('07) has pledged **\$75,000** to establish the D'Alemberte & Palmer Lecture in International Human Rights. The lecture series aims to attract giants in the field of international human rights: people who will make significant remarks that inspire students, contribute to the worldwide discussion, and advance the College

of Law's reputation as a serious participant in the field. Now retired, Palmer has previously served in Florida's legislature and governor's office, as a White House Staff member, and was a partner of D'Alemberte & Palmer, P.L.L.C., with her late husband, Sandy D'Alemberte.

Luis "Tony" ('95) and **Angela** ('95) **Cabassa** have committed **\$50,000** to establish the Gloria M. Cabassa Scholarship in Law. The scholarship will support students with financial need. The scholarship is a lasting tribute to Gloria Cabassa, who strongly valued education and made many sacrifices to ensure her son went to the best schools. Tony is a partner of Wenzel Fenton Cabassa, P.A., where he focuses his practice on employment law. Angela is of counsel with the firm Bush Graziano Rice & Platter, P.A., where she focuses her practice on long term care defense.

Florida Lawyers Legal Insurance Corporation (FLLIC) has committed **\$50,000** to establish the FLLIC Public Interest Scholarship in Law. The scholarship will provide financial support to students who have secured unpaid public interest legal positions in non-governmental





organizations. FLLIC was created in 1979 to promote the provision of legal services to persons unable to afford an attorney.

Judge Suzanne Van Wyk ('94) has committed **\$50,000** to establish the Van Wyk Administrative Law Scholarship. The scholarship will support students who demonstrate an interest in administrative law and have a financial need. Van Wyk serves as an administrative law judge with the Florida Division of Administrative Hearings. Previously, she was a shareholder in the Tallahassee office of Bryant Miller Olive. She is a past president of the College of Law's Alumni Association Board of Directors.

David Varet ('12) and the **Middle Road Foundation** have contributed **\$50,000** supporting the College of Law's General Fund. Varet is an assistant regional counsel with the Office of Criminal Conflict and Civil Regional Counsel's 5th District Office in Orlando. He is a member of the College of Law's Board of Visitors and the College's Alumni Association Board of Directors.

Margaret "Peggy" Rolando ('78) has made an additional contribution of **\$30,000** to her already established Peggy Rolando Endowment for Excellence. Endowments for excellence support the College of Law in the areas of greatest need. Peggy is a partner in the Miami office of Shutts & Bowen LLP, where she is a member of

the Real Estate Practice Group. She is a member of the College of Law's Board of Visitors.

An **anonymous donor** has pledged **\$25,000** to the already established James Madison Institute Scholarship. The scholarship supports students who promote ideals such as limited government, economic freedom, federalism, and individual liberty coupled with individual responsibility.

Rosalyn "Sia" Baker-Barnes ('00) has pledged **\$25,000** to establish the Shattering the Glass Ceiling in the Courtroom Fund. The scholarship will support female students who demonstrate an interest in civil trial practice. Baker Barnes is a shareholder in the West Palm Beach office of Searcy Denney Scarola Barnhart & Shiple, where she focuses her practice on personal injury, medical negligence, and product liability.

Scott ('98) and **Molly Smith** have pledged **\$25,000** to establish the Scott and Molly Smith Family Scholarship in Law. The scholarship will support students who are veterans, active, duty, or reservists in the U.S. military or guard. Scott is a partner of Smith, Ball, Baez & Prather, where he focuses his practice on personal injury and product liability.

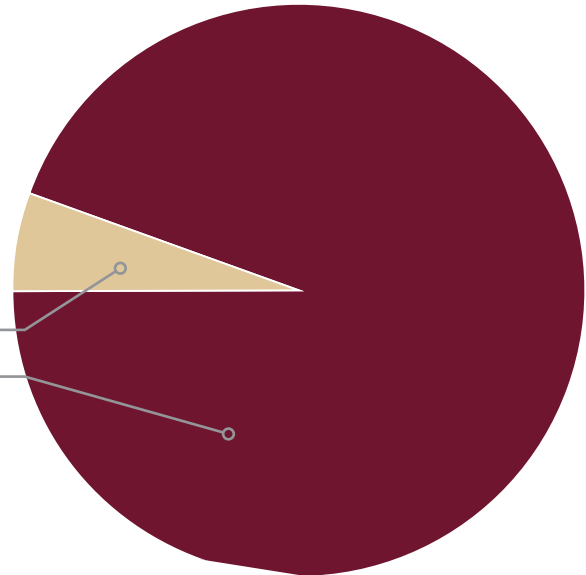

2022-2023 RECENT LARGER GIFT PLEDGES BY PURPOSE

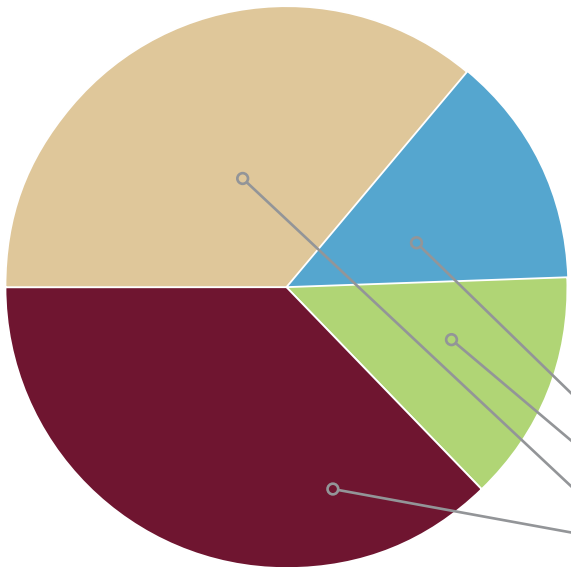

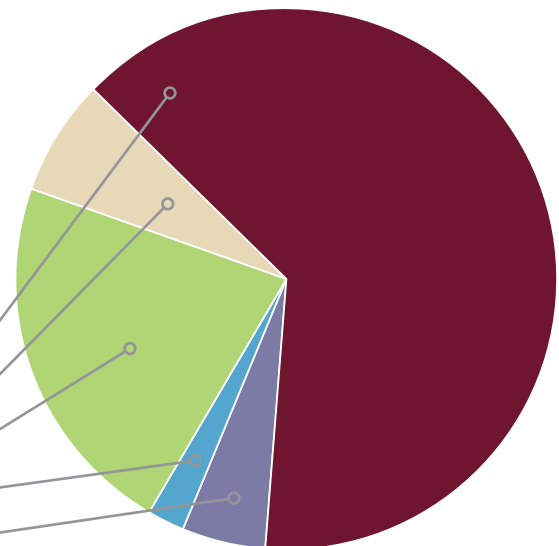

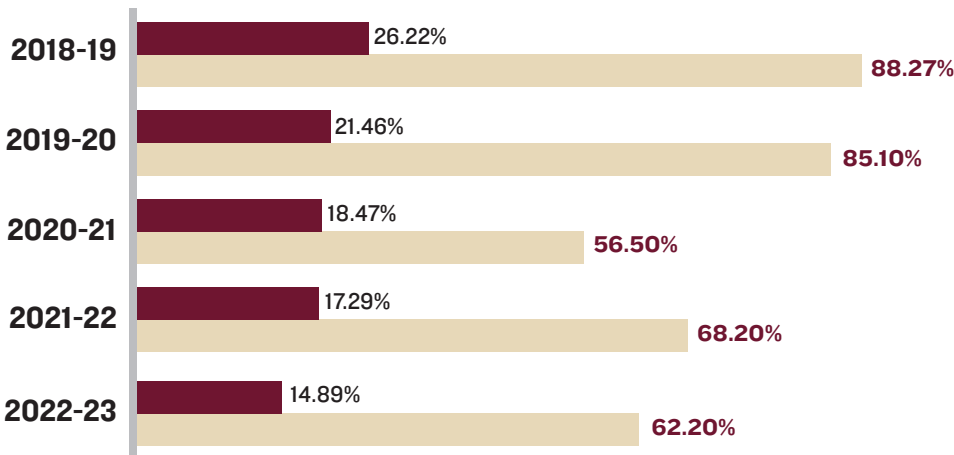
2022-2023 ANNUAL FUND AND EXPENDABLE CASH RECEIVED BY PURPOSE

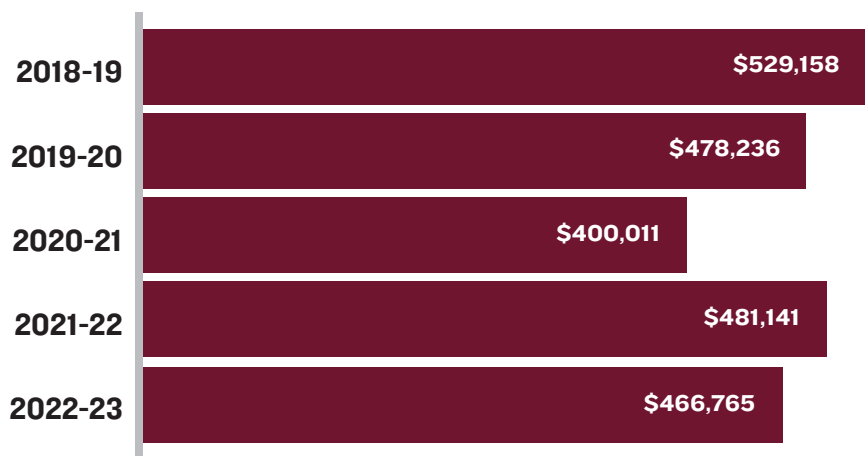


ALUMNI AND STUDENTS GIVING RATES
