During his lecture, he identified the kinds of fear and faith that catalyze environmental regulatory action, as well as the disparate fears and faith that foment legal constraints to check regulatory abuses. Considering the volatility of environmental law's most pressing challenges—including climate change, political vacillations, and changing dynamics on the U.S. Supreme Court—Professor Buzbee discussed how greater attention to the documentation of statutorily significant facts and science can help surmount the growing conflicts between the different sources of fear and faith. It was a fascinating discussion, and we are grateful to Professor Buzbee for talking to FSU Law students and others interested in his scholarship. Alum John J. Truitt ('10) John J. Truitt recently joined the GrayRobinson


University College of Law and as a visiting lecturer at Harvard Law School.


