### 50-Year Anniversary: 1972



In 1972, the *Florida State University Law Review* was founded and FSU Law's internship program expanded. Previously, students could not

represent clients in court or give legal advice. However, with the adoption of a greatly expanded student practice rule by the Florida Supreme Court in December 1971, students were permitted to represent clients in civil and criminal matters and the state of Florida in criminal matters. Before beginning their internships, all students had to be certified with the Supreme Court. Because of this expansion, the law school added prosecutor and attorney general internship programs to an already established public defender program. Also in 1972, FSU Law Dean Joshua Morse and two other legal advisers were invited to the capital of Saipan to help the Micronesian Congress set up a modern court system.

## Faculty & Alum Profile: Paolo Annino ('83)

Glass Professor of Public Interest Law Paolo Annino ('83) has been selected as the winner of the 2017 Father Robert Drinan Award! This national award is given by the Association of American Law Schools (AALS) Section on Pro Bono and Public Service Opportunities to a faculty member or administrator whose work on behalf of pro bono and public interest programs is truly extraordinary. A letter notifying Annino of the honor stated that the selection committee was struck by Annino's "longstanding commitment to addressing the legal needs of low-income clients, first as a legal services attorney and public defender and then as co-director of FSU's Public Interest Law Center and director of the Children's Advocacy Clinic." The letter also cited the impact of two projects Annino created that target the needs of Florida youth: the Children in Prison Project, created in response to the wave of Florida children being swept into the adult criminal system; and the Health Care Access Project, created to advocate for fragile children and developmentally delayed children. Annino has trained and mentored FSU Law students through our Public Interest Law Center since 1995.
