

50-Year Anniversary: 1976



Dean Emeritus and Alumni Centennial Professor Donald Weidner joined our faculty in 1976. Under his leadership, the law school climbed into the top tier of

U.S. law schools and was consistently recognized as one of the nation's best in terms of job placement. After 20+ years of leading the law school, Dean Weidner retired as dean in June 2016. Also in 1976, funding continued to be an issue for both FSU and the College of Law. In February, a group of about 100 law students marched in peaceful protest to FSU's administration building seeking emergency aid for funding the law school library. University President Stanley Marshall met with law students and said he would support their efforts to secure additional funding for the law school from the legislature and private sources. "I am the chief lobbyist for the university, but that doesn't preclude other people from doing this," the president was cited as saying in a Florida Flambeau article. Also in 1976, Carol Ann Turner ('77) was the first woman to serve as editor-in-chief of the Florida State University Law Review. She was one of the few women editors-inchief of law reviews in the country at the time.

Faculty Profile: Hannah Wiseman

Attorneys' Title Professor Hannah Wiseman has a new co-authored book that was published by Foundation Press in November. *Energy Law* provides a broad, yet detailed, understanding of the major components of energy systems, energy infrastructure, and energy markets and the laws that guide their development. It covers all major energy policy sectors including oil and gas extraction, electricity regulation, renewable energy development, and regulation of vehicles and transportation fuels. The timely book addresses rapidly changing policy in environmental regulation. Wiseman is a national expert on energy law, especially in the area of

the Black Law Students Association during his first two years of law school and was on the 2016 BLSA mock trial team that placed third in the southern region and advanced to the national competition. He currently serves as a research assistant for Professor Wayne A. Logan and has worked with him on two articles. They are also co-authoring an article forthcoming spring 2017. The summer after his 1L year, Falls interned with Stephen Knight at the Knight Law Firm in Tallahassee. Since August 2015 he has clerked at the Office of the General Counsel for the Florida Department of Business & Professional Regulation, Division of Alcoholic Beverages & Tobacco. Next semester, Falls will end his law school career with an externship at the Second Circuit Public Defender's Office in Leon County.
