50-Year Anniversary: Featuring 1992

Spring 1992 marked the premier issue of *FSU Law*, the law school's new alumni magazine. The inaugural issue featured beloved professor Patricia Dore, who had passed away in January. Professor Dore had been part of the FSU Law faculty since 1970, and was the law school's first female faculty member. "You all know by now that the quality of our program and the quality of our lives have suffered irreparable damage by the death of Pat Dore," said Dean Don Weidner in his opening letter of the new magazine. "This joyful woman, this consummate teacher, this indefatigable law reformer, this wonderful colleague, can



never be replaced." Since 1992, FSU Law has also hosted the award-winning <u>Donald J. Weidner Summer for Undergraduates Program</u>. The primary goal of the program is to acquaint students with the study of law and to assist them in acquiring skills that will benefit their undergraduate and future law school studies. Students gain classroom experience, learn about the law school admissions process and explore legal career opportunities. Thanks to the continued support and generosity of alum Wayne Hogan ('72) and his wife, Patricia, the program is endowed, allowing the approximately 60 participants to attend the four-week program for free. In 2016, the program was named for Donald J. Weidner, upon his retirement as dean of the law school.

Faculty Profile: Frederick M. Abbott



This past week the College of Law was host to an experts group <u>workshop on</u> <u>global pharmaceutical regulation</u>. The meeting was organized by <u>Professor</u> <u>Fred Abbott</u>, the Edward Ball Eminent Scholar Professor of International Law, who has worked for many years with international organizations, governments, nonprofit organizations and other stakeholders interested in promoting equitable access to medicines and other health products, as well as in exploring alternative innovation models. This meeting brought together experts from WHO, national health departments, an R&D partnership, industry and academia to develop strategies to address critical issues, including medicine prices that are straining public and private health budgets around the world – an issue that today is the focus of political attention in the United States. The meeting was convened on the 10th anniversary of a conference on Global Pharmaceutical Regulation held at the College of Law in 2007. Professor Abbott teaches an advanced legal writing seminar on Global Health and Pharmaceutical Regulation each spring.

"Research and development on new medicines, and their approval, production and distribution are a global undertaking, and important decisions affecting patients in the United States are made not only in Washington, but also in Geneva, New Delhi and Beijing. The discussions yielded important results, which will include the development of a briefing paper, a jointly authored work on a key issue, and the formation of an ongoing working group."

Throughout her 2L and 3L years, Salerno clerked for the Florida Department of Economic Opportunity's Office of the General Counsel, where she gained practical experience and was exposed to several different practice areas, including contracts, real estate, government grant programs and litigation.
