Three FSU law students recently placed in the final four at the national 2017 Startup LawMeet competition. FSU was one of 12 law schools invited to the national finals after performing well in qualifying rounds for which they produced four videos, answering questions for hypothetical clients about venture capital transactions for start-up companies. The finals were held in Palo Alto, California on March 24, 2017. Other law schools competing included Duke University, Northwestern University, University of California-Berkeley and University of California-Davis. During the finals, teams met with three experts playing the role of client during a 30-minute role-play. FSU team members were third-year students Clayton Culler, from West Palm Beach; Bennett Secrest, from Lexington, Kentucky; and Marianna Seiler from Ft. Lauderdale. Professor Richard Benham, Entrepreneur in Residence, coached the team. #### 50-Year Anniversary: Featuring 1994





Established in 1994, the Board of Visitors is an important support organization of the College of Law. Its members are typically major financial contributors who have funded student scholarships, professorships and law school programs. They

meet periodically on campus to interact with students and professors. Members also provide valuable insight into trends within the legal profession and how the law school can best prepare students to launch successful careers. Also in 1994, the law school received its first "major gift" when alumnus John W. Frost, II ('69), gave \$100,000 to establish the John W. and Ashley E. Frost Endowed Professorship. Frost has since given three additional major gifts to the FSU Law, most recently \$1 million in 2013. Additionally, Talbot "Sandy" D'Alemberte was appointed president of Florida State University in 1994, where he served until January 2003. He had served as dean of FSU Law from 1984-1989.

### Alumni Profile: Kenneth D. Pratt ('99)



Kenneth D. Pratt is the senior vice president of governmental affairs for the Florida Bankers Association (FBA), lobbying on behalf of Florida's banking industry in Tallahassee and Washington, D.C. Before joining FBA in 2011, Pratt was a senior lobbyist for the Florida League of Cities, served as the northeast deputy political director in the successful presidential campaign of Senator Barack Obama, and was a legislative aide for Florida Representative Geraldine Thompson. His legal experience includes practicing in the area of criminal law at Halim & Pratt, serving as an assistant public defender, and serving as an assistant attorney general in the criminal appeals division. Pratt is very engaged with the FSU College of Law. For several years, he has spoken to students in the Donald J. Weidner Summer for Undergraduates Program and in 2015, he met with J.D. students interested in governmental affairs during a Networking Nosh.

She conducted research, assisted in drafting articles for the Florida Sheriffs Association's *All Points Bulletin* and reviewed employment contracts for businesses and organizations throughout Florida. Last summer, she interned at Buckner, a sports and education law firm in Sunrise, where she researched and assisted in preparation for many NCAA investigations and drafted pleadings regarding commercial litigation cases.
