working on ways to enhance the career-related services we offer to students


and graduates. We are delighted to report that we recently added two new fulltime positions in our Career Services & Professional Development Office. This will allow us to provide more capacity for one-on-one counseling, as well as outreach to potential employers in Florida and elsewhere. Alum Kathleen Tuohy ('10) joined us in the fall as our recruiting and information manager. In addition to advising students, Tuohy is responsible for managing graduate employment data and the employer database, and directing our on-campus interview and resume collect programs. Earlier this month, we also welcomed Thomas Latino as our career advisor and employer development manager. Latino, who earned his J.D. from the University of Wisconsin-Madison, will travel frequently to recruit employers, focusing on out-of-state and federal employers, and will advise students seeking non-traditional, government and out-of-state opportunities. Students interested in cities in the Southeast will now have the assistance of our new part-time regional recruiter based in Atlanta, Sherri Rogers ('92), who will also help with targeted corporate and law firm employer recruitment. In addition, Assistant Dean Debra Henley ('87) and Career Advisor & Program Manager Lisa Duke are implementing several new programs this spring, including enhanced professional development workshops, improved student access to practice area and regional J.D. advisors, instruction on the effective use of the FSU Law Alumni Directory and tailored, one-on-one counseling and career search strategy sessions for each student. We know our students have the knowledge and skills necessary to hit the ground running in their careers, and now we have more resources to help them do that! School. He has also served as a law clerk for the Honorable Harris Hartz, of the United States Court of Appeals for the Tenth Circuit, for the Office of the Solicitor General and at the appellate staff of the Civil Division of the United States Department of Justice. As a law student, Bayern was editor-in-chief of the California Law Review. Before his legal career, Bayern worked in computing research, served on groups responsible for developing programming languages, and wrote several books and articles about computer programming. He also created the Central Authentication Service (CAS), a framework for computer security that has been adopted by many universities, including Florida State. "The law is often messy, and I try in my teaching and research to make it simpler. But it's important not to oversimplify. A lot of my research criticizes attempts to reduce the law to something too formal—say, a single economic or philosophical theory. As my students come to know, the common law is much richer than that."



Spratling received two Bachelor of Science degrees from Florida State University in 2002 and is a 2006 graduate of the Florida State University College of Law. 




