We are delighted to report that our FSU Law Moot Court Team won first place in the Seigenthaler-Sutherland Cup National First Amendment Moot Court Competition! Twenty-four law school teams participated in the competition, which took place March 23-24 in Washington, D.C., including teams from some of the nation's top law schools. Florida State beat South Texas College of Law Houston, which is ranked by *preLaw Magazine* as one of the nation's best law schools for moot court, in the final round of competition at the Newseum. Winning team members are 3Ls Brenda Czekanski and Jenna Von See. FSU College of Law alumni Jonathan Martin ('15), assistant general counsel at the Florida Department of Financial Services, and lan Waldick ('16), a staff attorney at the Florida Supreme Court, coached the team to victory. Martin and Waldick previously won a national moot court competition together in 2015 when they were law students at FSU. We are all so proud of our impressive student advocates and thankful for the efforts of their coaches!

Kyle B. Sill is an adjunct professor teaching International Sales and Arbitration this semester. He is also the coach for the FSU Vis Moot Team. He recently traveled with the team to Vienna, Austria, for the 25th Willem C. Vis International Commercial Arbitration Moot Competition, where the team met with record success. Sill is a senior law clerk for the Honorable Susan L. Kelsey of the Florida First District Court of Appeal. He previously served as a law clerk for the Honorable Scott Makar and as a senior law clerk for the Honorable Nikki Ann Clark, both of the Florida First District



Court of Appeal. Sill has taught as an adjunct professor at Florida Coastal School of Law and Florida State College at Jacksonville. He was also a senior lecturer of law at the Universitè d'Auvergne, Facultè de Droit, in Clermont-Ferrand, France. Sill's most recent scholarship and presentations have focused on appellate law, advocacy and persuasion. He holds a bachelor's degree in legal studies from the University of Central Florida and a J.D. from Florida Coastal School of Law, where he graduated *summa cum laude*.
