# Faculty Profile: Samuel R. Wiseman

Samuel R. Wiseman, the McConnaughhay and Rissman Professor, teaches Criminal Law, Criminal Procedure: Police and Gratuitous Transfers. His areas of academic specialty are criminal procedure, criminal law, constitutional law and food law. Wiseman's research focuses on pre- and post-trial issues in criminal procedure, including the use of DNA evidence, post-conviction litigation and the Eighth Amendment's prohibition against excessive bail. His scholarship has appeared in the *Boston College Law Review, George Washington Law Review, Minnesota Law Review, Ohio State Law Journal* and Yale Law *Journal*, among others. After graduating from



law school, Wiseman served as a law clerk to Chief Justice Wallace B. Jefferson, of the Supreme Court of Texas, and to Judge Fortunato P. Benavides, of the United States Court of Appeals for the Fifth Circuit. Wiseman also served as a fellow in the Texas Solicitor General's Office, focusing on post-conviction litigation before the Fifth Circuit. He joined the Florida State faculty in 2012. Wiseman graduated *summa cum laude* with a bachelor's degree in history from Yale University. He also holds a J.D. from Yale.

### Alum Profile: Francis H. "Frank" Sheppard ('84)

<u>Frank Sheppard</u> has served as managing partner of Rumberger, Kirk & Caldwell for the last 12 years. He works in the firm's Orlando office, where he focuses in the areas of professional liability, employment and commercial litigation. In addition to his trial practice, Sheppard handles appellate matters for clients in state and federal courts. He defends professionals against malpractice claims from a variety of industries, including legal, financial, real estate, construction and healthcare. Sheppard has handled many highprofile cases that involve complex issues, including claims for fraud, breach of fiduciary duty and statutory violations. He also



represents employers in cases involving claims of harassment, wrongful termination, retaliation and violation of civil rights, and has tried a number of such cases in state and federal courts. Sheppard is very involved in his community and in professional legal groups. He previously served on the law school's Alumni Association Board of Directors. Currently, he serves as chairman of the Hospice of the Comforter Foundation and is a member of the Florida Hospital Foundation Executive Board. Sheppard and his wife, Lisa, are actively involved in supporting other civic and non-profit organizations in the Central Florida community.

Rachel Stawski graduated from FSU Law in May. Originally from Saint Cloud, Fla., Stawski earned her bachelor's degree in English with a creative writing focus from FSU. Stawski was a member of the Student Bar Association, the Phi Alpha Delta law fraternity and the Women's Law Symposium. She also spent much of her free time riding and showing reining horses. Stawski attended the Alternative Spring Break



Program during her 1L year and participated in the toxic tour, pesticide training and human trafficking training. The summer after her 1L year, Stawski interned with the Association Law Firm in Orlando, where she worked on a wide range of projects for homeowner and condominium association clients and gained experience in property law. During the spring of her 2L year, Stawski interned for Florida Senator Darryl Rouson, where she researched proposed legislation and gained a greater understanding of the legislative process. During the summer after her 2L year, Stawski clerked at the Osceola County Attorney's Office in Kissimmee. During her 3L year, she interned for the Office of the General Counsel at the Florida Department of Agriculture and Consumer Services. In this role, she researched, drafted pleadings, created memoranda and assisted in drafting legislation. Stawski also wrote an article in her Animal Law class that was later published by The Florida Bar Animal Law Section in their winter 2017 Paw Review newsletter.
