He has taught Civil Procedure, Public International Law, Conflict of Laws, Comparative Constitutional Law, Constitutional Law I, and International Litigation and Arbitration. As associate dean for international programs, Landau is in charge of the graduate LL.M. Program in American Law for Foreign Lawyers and the Certificate Program in International Law for J.D. students. He is the author of several books, book chapters, articles and essays. Landau's recent work has focused on democratic transitions and the potential risks of constitutional amendments and constitution-making for democracy, as well as on judicial activism on socioeconomic rights issues





He is co-editor of the just-published book, The Evolution of the Separation of Powers, and has published in various journals, including the Chicago Law Review, the Harvard International Law Journal, and the International Journal of Constitutional Law, where he is on the scientific advisory board and is a founding editor of *IConnect*, the blog of the journal. In 2011, Landau served as a consultant on constitutional issues for the Truth and Reconciliation Commission of Honduras. Landau holds an A.B. and J.D., magna cum laude, from Harvard University. He also earned a Ph.D. in political science from Harvard in 2015. He has been a member of the FSU Law faculty since 2010. 
