Her research interests include health, risk and regulation, and law and economics. Her publications include articles in the Journal of Risk and Uncertainty, the Journal of Health Economics, and the American Law and Economics Review. Gentry's research focuses on issues relating to pharmaceutical and device regulation, physician learning and the value of a statistical life. She will teach Health Law this fall. Gentry previously served as a postdoctoral research fellow at the Institute for Advanced Studies in Toulouse, France, and as a judicial clerk for the Honorable Jane Roth of the U.S. Court of Appeals, Third Circuit, in Philadelphia. She earned a bachelor's degree in human and organizational development and economics from Vanderbilt University. Gentry also holds a J.D. and a Ph.D. in law and


