

Alum Profile: Shane Spencer ('16) (1991-2020)

Shane Spencer, 29, passed away on June 1, 2020 as a result of a fatal car accident. Spencer was an associate at Cole, Scott & Kissane in Tampa, where he had worked since 2016. Spencer concentrated in the areas of premises liability, vehicle negligence and sex trafficking/human trafficking defense. According to the firm's site, Spencer "was one of the brightest associates and a privilege to have with the firm." He was also a member of the Hillsborough County Bar Association. Spencer graduated from FSU Law in 2016 and Central Michigan University in 2013. While in law



school, Spencer was a mentor for the Donald J. Weidner Summer for Undergraduates Program, and a member of the Sports and Entertainment Law Society and the Student Bar Association. He also graduated with a distinguished pro bono service award for his volunteer work with the Office of Criminal Conflict and Civil Regional Counsel. He loved sports and was a huge fan of Tom Brady. Spencer was born in Macomb, Michigan. A mass will be held today, Friday, June 12, 2020, at 12 p.m. at the St. Malachy Catholic Church in Sterling Heights, Michigan, followed by a celebration of life from 3-10 p.m. at the Spencer residence in Macomb, Michigan. The celebration of life will continue on Saturday, June 13, 2020, from 11 a.m.-10 p.m. at the Spencer residence.

Student Profile: 2020 Grad Brandon Gamble

Desired Practice Location: Tallahassee; also open to Palm Beach County, Broward County or the Orlando area

Field of Law Sought: Would like to practice plaintiff's personal injury law; would also consider insurance defense work or immigration law

Originally from Loxahatchee, Florida, just west of West Palm Beach, Brandon Gamble became



a double 'Nole when he graduated from FSU Law last month. He also earned a bachelor's degree in religious studies and history from

FSU. During the spring semester of his 3L year, Gamble participated in the Public Interest Law Center Immigration and Farmworker Project. There, he became familiar with immigration court and was able to help indigent clients apply for and obtain humanitarian immigration relief. During the summer after his 2L year, Gamble clerked with Searcy Denney Scarola Barnhart & Shipley's Mass Torts Division in West Palm Beach. He quickly discovered the complexity and novelty of the mass claims system, drafted and responded to discovery and pleadings, and conducted client interviews. Gamble's work primarily focused on the 3M Combat Arms Earplug litigation. From the summer after his 1L year and through his 2L year, Gamble clerked for Fasig|Brooks, where he worked on discovery and pleadings in personal injury plaintiff's litigation. As a nontraditional student, Gamble's path to law school was unique. He spent a few years in the restaurant industry after undergrad. Wanting a change, he took a full-time job as a runner at a law firm, but still worked part-time at a restaurant to make ends meet. Soon, Gamble worked his way up to paralegal, assisting a lead attorney with the management of a case load of 70-100 litigation and prelitigation cases. He found the work exciting and intriguing, and he decided to take the next step and become a lawyer himself.

During law school, Gamble started an FSU section of the Florida Justice Association (FJA) and served as its president for a year and a half. The purpose of the FJA at FSU is to involve students in the FJA's mission to strengthen and uphold Florida's civil justice system and protect the rights of Florida's citizens and consumers. Machaella Reisman is originally from Raleigh, North Carolina. She holds bachelor's degrees in political science and marketing from Clemson University and graduated from FSU Law in May 2020. Currently, Reisman is a clerk for Young Qualls, P.A., where she has been researching and drafting memos, assisting in litigation and drafting documents—including complaints, motions and appellate briefs—since May



2019. During the spring semester of her 2L year, Reisman externed for the Leon County Attorney's Office. She attended county meetings, including those of the board of county commissioners (BCC), drafted memos to the BCC, assisted in county ordinance revisions and helped draft contracts. The summer after her 1L year, Reisman was a judicial intern for Judge Robert E. Long, Jr. of the Second Judicial Circuit of Florida. She drafted legal memos, observed trials and hearings, and completed case management projects.

Reisman was a member of the Phi Delta Phi honors society and the Business Law Society, where she served as activities chair during her 2L year. She was also a member of the Moot Court Team and competed in the UCLA Cyber Crimes Competition during her 2L year. Reisman and her partner won Best Petitioner's Brief at the Gibbons Criminal Procedure Competition this spring, although the in-person competition was canceled. Reisman is interested in practicing privacy law and completed a directed independent study with Professor Jake Linford this spring. She wrote an article on higher education and student privacy, for which she is currently seeking publication. Reisman is sitting for the July 2020 administration of the North Carolina bar exam.
