From the Dean

I am honored to report that FSU President Emeritus, Dean Emeritus and Professor Talbot "Sandy" D'Alemberte, who passed away in May 2019, will be posthumously awarded Florida State University's highest distinction, the James D. Westcott Distinguished Service Medal, later this month. The honor recognizes a "person whose distinguished service merits exceptional recognition and whose life and work exemplifies the Vires, Artes and Mores, which the university seeks to nurture in its students." It has been 11 years since FSU last bestowed the award.



Sandy will be awarded the medal posthumously in a private ceremony September 22. Sandy's service to Florida State and the law school was extraordinary. He served as president of the university from 1994–2003, overseeing a period of remarkable growth and revitalization, which included helping to establish the College of Medicine, undertaking a major campus beautification project and creating the Center for the Advancement of Human Rights. Sandy served as dean of FSU Law from 1984–1989, raising the profile of the law school and transforming our programs and physical facilities, including the Rotunda building now named in his honor. His contributions to our school and the university at large still benefit students across campus today and will continue to do so for many years to come.

Dean O'Connor Named Registrant Advocate for Florida Bar Examinees

Last week, the Florida Supreme Court named FSU Law Dean Erin O'Connor as the Registrant Advocate to work with Florida Bar examinees



unable to take the 2020 summer bar exam due to pandemic test failures. The new Registrant Advocate position was created after the regular July 2020 Bar Exam was canceled due to health and safety concerns in the coronavirus pandemic. A rescheduled August exam was later canceled because of failures in an online testing system. The exam is currently scheduled for October 13. Examinees can use an <u>online</u> form to contact both the Registrant Advocate

and the Florida Board of Bar Examiners about issues such as software or testing accommodations. Or, they may contact the Registrant Advocate anonymously by email at <u>RegistrantAdvocate@flcourts.org</u>.

Dean O'Connor is also pledging to match donations up to \$1,000 for a new fund the FSU College of Law created to help the graduates experiencing job losses and other hardships associated with the delayed exam. Under the "In Memory/In Honor" section of the form, note "Bar exam grads" in the Name field to ensure gifts get to the alumni who need support.

"Our recent graduates are in a tough spot, so I am devoting my time and income to assisting them," said Dean O'Connor. "I invite our alumni, as members of our FSU Law family, to do the same."
