#### Prof. Krieger Celebrates 30 Years with FSU

Since 1991, <u>Professor Larry Krieger</u> has served as a clinical professor at FSU Law. Teaching for 30 years is a remarkable accomplishment that translates into Krieger having taught hundreds of College of Law alumni. As



co-director of externship programs, Krieger has supervised all criminal justice externships and has helped even more students attain valuable trial

practice skills and experience that they have carried with them into their legal careers. In addition to preparing students for the courtroom, Krieger has been instrumental in promoting wellness at FSU Law. He is internationally recognized for his research on the well-being, satisfaction, values and motivations of law students and lawyers, which has been extremely beneficial for FSU Law students. Krieger often presents to the student body on mental health and wellness topics, hosts weekly meditation sessions for students during the academic year, and makes himself available to students who may be looking for advice, inspiration or encouragement. The summer after Whiting's 2L year until graduation, he worked as a research assistant

to Professor Jay Kesten. In this role, he conducted research on various topics concerning corporate and business law and edited academic work in preparation for submission to professional journals. He also analyzed and produced case briefs on various cases and articles dealing with master limited partnerships, initial public offerings and venture capital funding. The summer after his 1L year until November 2019, Whiting worked for the Florida Department of Business & Professional Regulation in Tallahassee as a paralegal specialist/law clerk. His work primarily consisted of filing over 200 closing orders and administrative complaints dealing with unit owners and community association managers' issues. During his time at FSU Law, Whiting was a member of Phi Alpha Delta, the Entertainment, Arts and Sports Law Society, the Black Law Students Association, The Florida Bar YLD Law Student Division and the Business Law Society, where he served as vice president.
