Employers Interview FSU Law Students



Employers are recruiting FSU Law students through the fall 2021 interview program.

During the first week of August, FSU Law began hosting employers for the fall 2021 interview program. More than 80 employers have already signed up for the program to recruit students virtually and in person for summer clerkships and post-graduation positions. Participating employers include large and small law firms, state attorney and public defender offices, businesses, and government agencies. During the first few weeks of the interview program, the Career Services Office has received very positive feedback from employers about students they have interviewed, and students have already been scheduled for second interviews. The interview program runs until November 5, so there is still time to sign up to recruit FSU Law students. Prime dates for interviews typically fill up fast, so the Career Services Office recommends registering as soon as possible.
