

With one week left in the 2022 program, students have already toured the Florida Capitol, met with and received advice from many influential, engaged FSU Law alumni—including Judge Nina Ashenafi-Richardson ('91) and program benefactor Wayne Hogan ('72), attended oral arguments at the Florida Supreme Court, participated in Legal Writing, Criminal Procedure, and Lawyers as Leaders law classes, and learned about various components of the law school admissions process. Before the program ends on June 24, students will also present their own oral arguments and attend a special premiere screening of Netflix's CIVIL, a documentary about FSU Law alumnus Ben Crump ('95). 
