Career Advisor Participates in USMC Educators' Workshop



Earlier in June, Manager of Employer Development & Career Advisor Thomas

Latino attended the U.S. Marine Corps Educators' Workshop at Marine Corps Base Quantico in Virginia. The unique five-day event provided educators from priority colleges and universities an opportunity to learn how Marine officers are recruited from a pool of highly qualified students, trained, and developed into leaders. The program was designed to demystify recruitment and officer candidate training and foster stronger relationships among recruiting personnel and the communities they serve. Latino's schedule included sessions on officer candidates school, a visit to the Marine Corps Air Facility Quantico with flight orientation, participation in the leadership reaction course, indoor simulator marksmanship training, and a visit to the National Museum of the Marine Corps. Latino plans to use the training he received to better counsel FSU Law students who are considering Judge Advocate General (JAG) service. "This experience was one of the most transformative of my career," said

a unique perspective on what it takes to be not just a JAG but also a USMC JAG. The standards for acceptance are stringent. However, if a student is fortunate enough to be appointed a USMC JAG, the skills that student will develop over the course of their four years—leadership, mentorship, managing a team, working under pressure, managing tight deadlines, and developing an effective strategy from fragments of incomplete information—along with their legal education, will transform them into a fundamentally different person. There is not an employer from Maine to Honolulu that would not want someone like that in their organization.
