# Faculty Profile: James Parker-Flynn (LL.M. '14)

James Parker-Flynn recently joined the FSU Law faculty as director of the Center for Environmental, Energy, and Land Use Law. Parker-Flynn specializes in environmental and energy law, with a focus on climate change-related issues. He is teaching Energy Law and Policy during the fall 2022 semester, and he will teach Land Use Law and a new Environmental Justice Seminar during the spring 2023 semester. Before joining the faculty, Parker-Flynn practiced law with Carlton Fields, where he specialized in appellate practice, land use litigation, and environmental law, assisting



clients with a wide array of regulatory and litigation issues. He has handled environmental and land use litigation in Florida's state courts and administrative forums, and he has worked on a variety of appeals and other litigation in state and federal courts around the country. He has published several articles on climate law and policy, and frequently speaks about climate-related issues at seminars and other CLE events. Parker-Flynn earned an LL.M. in Environmental Law from FSU, after receiving his J.D. from Georgia State University.


