Faculty Profile: Preston McLane ('09)

Preston McLane has joined FSU Law as an attorney advisor and visiting professor. McLane will teach in the law school's environmental law program. He is currently a program administrator with the Florida Department of Environmental Protection's Division of Air Resource Management. His responsibilities range over many key programs under the Clean Air Act, including managing the State Implementation Plan development and revision process, rulemaking, regulatory planning, budget development, grant program development, and coordination with the U.S. Environmental Protection Agency on matters relating to Florida's attainment and



maintenance of the National Ambient Air Quality Standards. He will share his expertise on practicing public environmental law as one of our featured alumni panelists in the Spring Careers Panel to be held at the law school in January, and he is currently available to counsel students one-on-one. McLane graduated from FSU Law in 2009. "I am excited to join the environmental law program faculty

at the FSU College of Law, and I look forward to helping students learn more about environmental law practice and career paths in both the public and private sectors."
