

of alleged drug paraphernalia in accordance with recent updates to federal court interpretations, assisted the plaintiff's counsel in a constitutional challenge to statutes and regulations prohibiting medical marijuana patients from purchasing or possessing a firearm, and conducted research on the history of marijuana and gun regulations to support the plaintiff's constitutional challenge. Lusk has also worked in the areas of administrative and corporate law at Dean Mead. She performed research for a petitioner in a multi-party certificate of need case with significant discovery and assisted attorneys with entering a final order declaring a proposed rule to be an invalid exercise of delegated legislative authority. Additionally, she prepared memoranda on claims for quantum meruit, tortious interference, unjust enrichment, and oral contracts for a contract dispute concerning a medical marijuana dispensary. During the summer before her 2L year, Lusk was a judicial extern with the Second Judicial Circuit of Florida. In this role, she assisted with domestic violence



proceedings and injunctions as well as with research in a tort case with substantial damages. At FSU Law, Lusk has served as a research assistant in the Research Center since June 2021 and has performed pro bono work with the Farmworker and Immigration Rights Clinic.
