

reception. The first Ellis Medal will be awarded during the event to an FSU law student committed to international human rights. Mora served as general counsel of the United States Navy from 2001 to 2006, and he

recently retired as a senior fellow at the Harvard Kennedy School of Government's Carr

Center for Human Rights Policy. During his tenure at the U.S. Navy, Mora led efforts to end the use of cruel and unlawful interrogation practices at Guantanamo Bay. He received the John F. Kennedy Profile in Courage Award in 2006 in recognition of his opposition to the torture of detainees. In 2013, Mora was also included in a book, "Justice," as one of 99 individuals worldwide who have made a significant contribution to human rights. 

## Recognized as One of the Best in IP Law

written by two FSU Law professors and an alumna as one of the best works of recent scholarship relating to intellectual property law. For their paper, *Trademark Tarnishmyths*, Loula Fuller and Dan Myers Professor Jake Linford, Charles W. Ehrhardt Professor of Litigation Justin Sevier, and FSU Law alumna Allyson Willis ('21) conducted two experiments on trademarks to determine if tarnishment on a seller's reputation occurs when affiliated with disreputable topics. Based on the results of the experiments, the authors suggest that the case for tarnishment might be weak in circumstances where courts have been most willing to presume tarnishment occurs. Further, they argue that much of what courts have presumed about the tarnishing effect of sex-, drug-, and sacrilege-related uses may be more mythic than material. The JOTWELL review of *Trademark Tarnishmyths* concluded that the article is "a very valuable addition to the trademark dilution literature."


