# From the Dean

During the upcoming academic year, we are introducing exciting courses related to technology and the law. This fall, we are offering a course that will introduce law students to the intersection of law and technological innovation, exploring the legal implications and challenges posed by emerging technologies. Students enrolled in our Law and Technological Innovation course will gain a comprehensive understanding of how the law interacts with technological advancements and learn to analyze and address legal issues arising from disruptive technologies. The course will cover a range of topics, including intellectual property,



privacy, cybersecurity, artificial intelligence, blockchain, and the regulation of emerging technologies. We are delighted to welcome Katya Fisher, who serves as executive vice chairman of Constructor Group, to teach Law and Technological Innovation at the law school this fall.

In the spring, we will offer Artificial Intelligence and the Law, taught by alumnus Ben Odom, who serves as vice president – business and legal affairs for NASCAR, and Rich Harper, who is partner-in-charge of the New York Office of Baker Botts, L.L.P. The seminar will equip students with the knowledge and skill set to address the intersection of artificial intelligence (AI) and the law. It will focus on a variety of Alrelated legal issues, ranging from which governmental agencies are and will likely be regulating AI to a discussion of data privacy, intellectual property rights, and contract and tort liability issues arising from the use of AI.

These new courses are being offered in conjunction with the establishment of our Law & Technology Institute, which will provide opportunities for academics, practitioners, and students of various disciplines to collaboratively examine the promises of evolving technologies outside the law, while also highlighting the role of law and legal ethics in our digital world. ### Alum Profile: Travis A. Voyles ('17)

Travis A. Voyles began serving as the Commonwealth of Virginia's secretary of natural and historic resources in March, after serving as acting secretary for one year. As secretary, he serves on the governor's cabinet overseeing five state agencies and working to advance the governor's top environmental priorities. He also serves as the chief resilience officer for the state and is part of the governor's leadership team on energy and economic development issues. He previously served as oversight counsel for the U.S. Senate Committee on Environment and Public



Works, where he led the committee's work on environmental, energy, economic development, and infrastructure issues. He also served in multiple appointed roles at the U.S. Environmental Protection Agency, including acting associate administrator for the Office of Congressional and Intergovernmental Relations and director of oversight, and he worked for the U.S. House of Representatives Committee on Science, Space, and Technology.

"I have been extremely fortunate to work at the federal and now the state level on issues that I have been interested in for most of my life. Whether working with farmers and developers to improve water quality or ensuring expanded access to parks or hunting and fishing opportunities, I have been able to apply my legal and policy background to an ever-growing range of natural resource issues. At FSU Law, Alvarez is a student ambassador with the Office of Admissions and a member of the Cuban American Bar Association and Hispanic Law Student Association. He spent the 2022 summer semester participating in the law school's Summer Program in Law at Oxford, and upon his return, he joined the Jessup Moot Court team as a student coach. Alvarez transferred to FSU Law from Florida Coastal School of Law, where he was a member of the Mock Trial Team and began the Music and Business Law Society, serving as co-founder and treasurer.
