Carlos Lindo is senior vice president of legal and compliance at Lucet, a company that provides innovative and accessible behavioral health solutions. In this role, Lindo leads the company's legal department and serves as corporate secretary and executive sponsor of the Diversity, Equity, and Inclusion Committee. He oversees all legal and regulatory matters related to Lucet's products, services, contracts, and partnerships, and he advises the executive team on strategic decisions, corporate governance, and business development. Prior to joining Lucet in 2017, Lindo served as associate corporate counsel for Xerox, Inc., where he specialized in the administration of Medicaid



contracts and subrogation under the healthcare arm of Xerox. He also was an associate at Pumphrey & Prince, where he handled criminal cases, including first-, second-, and third-degree felonies and misdemeanor cases. Lindo remains engaged with the law school and currently serves on the FSU College of Law Alumni Association Board of Directors.

Alison "Ali" Dukstein is from Oviedo, Florida, and she earned her bachelor's degree in political science with a minor in German from Rollins College. During the summer before her 3L year of law school, Dukstein was a certified legal intern at the Second Circuit Public Defender's Office, where she managed a caseload of approximately 60 cases. She represented and advocated for clients through negotiation with the prosecution, filing and arguing motions, and in trial. Also in this role,



Dukstein worked with Tallahassee Memorial Hospital to ensure one of her clients who struggled with Schizophrenia and hearing loss—would be provided a service dog if her case went to trial. The hospital approved her request, providing their services to a client of the Public Defender's Office for the first time. Dukstein also sat second chair on a battery trial, in which she presented the opening statement, cross examined the arresting officer, and successfully moved for a Richardson Hearing and mistrial. During the summer before her 2L year, Dukstein was a legal intern at Joshi Law Firm, PA in Orlando, primarily working under the supervision of Samantha Angelastro ('19). There, she conducted legal research, reviewed discovery for various criminal cases, organized trial binders, and visited clients in jail to discuss their cases. She also assisted with a week-long first-degree murder trial, which included helping with jury selection.

At FSU Law, Dukstein is vice president of the Trial Team and has been a member of the team since the spring of her 1L year. She served as the team's competition chair last year, was a finalist in the 2022 Wayne Hogan Intramural Competition, and received an honorable mention in the 2022 All-Star Bracket Challenge. Dukstein is also fundraising coordinator for the Association for Criminal Justice and a member of the Women's Law Symposium and Student Bar Association.
