The program is the largest and oldest of its kind, and its primary goals are to acquaint students with the study of law and to assist them in acquiring skills that will benefit their undergraduate and future law school studies. The program has been honored twice with the American Bar Association's Raymond Pace and Sadie Tanner Mossell Alexander Award for Excellence in Pipeline Diversity. Additionally, Charles previously served as a teaching assistant for Legal Writing I, assisting students in developing strong legal writing skills, and for the Juris Master Program's Employment Law and HR Compliance class, a role that included conducting research for course content, drafting a grading rubric template, answering questions about the materials, grading papers, and providing student feedback.
