## **Alum John R. Jenkins '84 Retires as Executive Director of Bonita Springs Utilities**

FSU Law alum John R. Jenkins ('84) recently retired as executive director of Bonita Springs Utilities, Inc. (BSU). As executive director, Jenkins oversaw the operations of the company's various departments and carried out the policies of the board of directors. BSU has over 130 employees and provides over 31,000 members with water and wastewater services to the City of Bonita Springs, the Village of Estero, and the townships of South Lee County. Prior to joining the utility company, Jenkins practiced law for 30 years, focusing on public utility law and Florida water and wastewater utilities. While in private practice, he served as special counsel for BSU, working on a variety of issues, including rate setting, revenue bond financing for capital projects, tax exempt status, developer agreement and contract drafting, franchise issues, wastewater system expansion, environmental matters, and real estate matters. Jenkins frequently spoke to local business and civic organizations about BSU and its operations. He is a member of The Florida Bar Environmental and Land Use Law Section, the American Water Works Association, and the Water Environment Federation.
