## From the Dean



Kole Kolasa was born in Big Lake, Minnesota. He attended Florida State University where he obtained a BS degree in economics, *Magna cum laude* as well as a master of science in applied economics. At FSU Law, Kolasa is the editor-in-chief of the FSU Law Review. He is also the chief justice of FSU Student Government Supreme Court and a staff editor of the FSU Business Review. Kolasa is a member of the William Stafford Inn of Court. He also mentors and serves as a house coordinator for one of our new 1L houses.

Kolasa currently works as a law clerk at Henry Buchanan where he drafts legal documents and conducts in-depth research and analysis on labor and employment, medical malpractice, and insurance defense. He has prepared various motions, including for summary judgment, initial briefs, developed detailed deposition outlines, and utilized technological skills to manage and analyze media files. This past summer, he was a summer associate with Bleakley Bavol Denman & Grace where he conducted legal research, drafted legal documents, and provided analysis on diverse issues related to civil defense, residential and commercial real estate, construction defect, breach of contract, insurance defense, and business litigation. He also contributed to the firm's summer competition by deposing a senior partner, drafting an original research memorandum, and conducting *voir dire* to empanel a jury. Since May, 2023, Kolasa also continues working as a teaching assistant and reviews course material to prepare for grading student submissions and provides substantive feedback regarding students' work. He has worked in this capacity for the following classes: Torts; Conducting Workplace Investigations; Consumer Compliance; Lending; and Regulatory Compliance.
